Requirements

1. Subject-matter: BAGL-afFAIRs 2010 (there is no special topic for the exhibition.)
2. Every artist with a significant homepage can apply for this exhibition. The following mandatory fields must be full completed.

3. The head of organisation of BAGL 2010 wants to create a round and versatile exhibition. It is broad-minded with the Idea of less is more! Preferred are one or two works or compact and consistent shown series. The head of organization of BAGL chooses the participants with the ambition, to create an interesting exhibition for the audience. The final decision of the head of organisation is no valuation of arts; there is no possibility for rescission.
4. **Deadline fur Application is Wednesday, March 17, 2010.**
The attendance fee 350,00 €.
5. In co-payment of 35,00 €, artists can present their arts in two pages of the official exhibition catalog.
6. The chosen artists will be informed after March 22, 2010. The works of the selected artists must be sent in JPG 300 dpi combined with the application. The artists have to name two of the works with name of the artist, work title, year of formation, execution, size and price for the catalog. The deadline for payment of the attendance fee of 350,00 € is on demand April 15, 2010 (receipt of payment!). The artists get the account number combined with the affirmation. If the payment is out of time the invitation to the exhibition is no more valid; there is eventually the possibility of repayment moiety of the attendance fee.
7. Alternatively every artist can also use floor ground (2,5 x 2,5 m) or a wall area (width ca. 3 m, height 2 m). preference of canvas, the canvas must be ready for adherence. (rearly eyed and hitched for galleries).
8. Every attendant is responsible and on charge for duly installation and depletion of his works. Every work must be marked on the back with name, email and price. The attendants have 4 days for installation. and two days for depletion, in each case from 10am to 7pm. 'The accurate date of start will be notified in beginning of June 2010.
9. In agreement the artist can use movable walls if they fit in the master plan of exhibition. After the use of the walls they have to be in good order and condition of before-use.
10. The artists will be informed in due rime of address and times for delivery of works.
The attendance fee decays if the works aren't delivered in the agreed period till one day before opening the exhibition. If the artist has no possibility to install and deplete his works in person there is a possibility to agree with the head of organisation of BAGL to deliver the works on one's own account unless 7 days before opening. This kind of delivery must be especially agreed and

documented with the head of organisation of BAGL. The artist have to pay a separate fee of 50,00 € + shipping for Installation, depletion, packing and shipping of none-sold works.

11. None-fetched Works after three days from the End of exhibition or without any documented agreement for shipping, will be stored for four weeks for a fee of 50,00 € until they become property without substitution of BAGL.
12. Please send us a signed copy of this agreement after getting the covenant of the BAGL for the exhibition to: info@bagl-artists.de and please pass us one another copy of this agreement combined with the delivery/shipping of the works,
13. The artists are in own charge to procure insurance during transports installation and depletion of works,
14. The sales commission of BAGL is 25% of the price in the pronounced pricelist. Proceeds of the sales after taking the commission of 25% will be sent per cheque to the recipients/artists.
